### General

The website Wild Moon Lilith and any services offered therein are offered by Nadia L. Bond (in this document referred to as I/me) as the sole provider.

Any payments are to be done through PayPal for the protection of both you and me and follow the PayPal guidelines for transactions and transfers. These payments are between you and I, as private people, for services offered for entertainment purposes.

I reserve the right to modify these terms of service at any time, however the most recent version will always be attached to the initial automatic mail-response and can also be given upon request. Changes and clarifications will take effect immediately upon their addition to this document.

### Readings

#### The Service

I will always offer truthful, honest readings that are based solely on the cards guidance, other tools and intuitive/psychic impressions given to me. I will not use any methods such as “foul play” to obtain any information about you, such as researching you or otherwise giving a so called “cold reading”.

I offer clarifications for free up to 24 hours after the reading, for anything that is unclear within the reading itself. I do not offer any answers to follow-up questions that would require me to continue the reading.

I do not offer any returns or refunds for readings that are already carried out or otherwise initiated. Your payment is considered a donation in the form of an energy exchange for the work I have put into the reading, and thus will not be refunded if you feel dissatisfied with your reading due to any reason.

Readings are carried out by me within 72 hours after payment has been received through PayPal, unless otherwise stated prior to payment. I reserve the right to change this deadline under certain circumstance which would hinder me from completing the reading within due time, however, in such cases you will be notified of this delay, unless something so severe has happened to me that I cannot reach out. However, should the reading take longer than 96 hours without any notification of delay, I

will offer a full or partial refund depending on the circumstances and whether or not I could complete the reading at all.

## **Terms**

By paying for a reading you acknowledge that readings work as a guidance and for entertainment purposes. If you have any concern for your health, financial security or well-being in any other shape or form, you acknowledge that it is your sole responsibility to seek out a professional or otherwise handle your situation; I am in no shape or form responsible for what you choose to do with the received reading.

You agree that a reading is not set in stone, and agree to take full responsibility of any consequences, actions or outcome of the reading.

You further agree that readings will sometimes give you information you might not consider beneficial or wanted; a reading is therefore booked by your own discretion with full responsibility on your own behalf.

You agree to only submit information that is truthful about yourself and in no way seek to lie, alter the facts or otherwise mislead me to get a reading for a third-party person. Readings will only be given to you, as you give your consent for this – no third-party readings! The only exception is for the dearly departed.

## **Reiki**

### **The Service**

I will, on a set time and date, perform a full 45-minute Reiki session for you over distance, unless agreed otherwise. I will use my training as a Reiki Master to perform the Reiki healing session to the utmost of my ability, and you can rely on the fact that it will indeed be performed as agreed upon.

If for any reason I cannot perform the Reiki session on the agreed-upon time, you will be notified as soon as I can, and you will be offered a rescheduling up to 3 (three) following times or offered a full refund. Same will apply if you miss a scheduled appointment, with the exception that you will get 1 (one) chance to rebook the appointment before being offered a full refund, and only if you notify me in advance. Otherwise, the Reiki session will be carried out as planned and there will be no issued refund, as the service still will be performed even if you are not in a state to receive.

I do not offer returns or refunds for Reiki that has been performed. Your payment is considered a donation in the form of an energy exchange for the work I have put into the reading, and thus will not be refunded if you feel dissatisfied with your reading due to any reason. Reiki is sometimes not felt by the recipient, with any benefits being noticed later on. For some, Reiki is a relaxing activity – there are no promises of cures or miracles here!

By paying, you agree that Reiki healing is not a substitute for proper medical treatment and should be treated as relaxation and an act of self-love and holistic well-being. You agree to always rely on medical professionals for medical issues. Reiki is a wonderful healing art, but you take full responsibility for your own health and the actions taken to maintain your well-being.

You agree to not rely solely on Reiki for serious medical issues. You are solely responsible for your health and any choices and consequences thereof. I am in no way liable nor responsible for any health complications, consequences or negative changes to your health after the Reiki session.

## **Spells**

### **The Service**

I will carry out the spell as described in our communication before the service has been booked. I reserve the right to not disclose the full details of how I perform the spells as they are highly personal; you will, however, receive pictures if applicable as well as general information about the spell such as its purpose and some general information.

I will carry out the spell within the allotted time, as agreed upon in our communications. If there is a delay to the spell, you will be notified and given the offer to continue with the spell, or to cancel and receive a refund.

You can rest assured that the spell will be performed, as I take this sort of work seriously and put a lot of pride into this service – it is tied to my personal religious and spiritual worldview. Performing the spell is a matter of ethics for me.

I will offer after-care information after the spell is performed, such as confirming the spell has been cast, and any possible advice that might help you keep up the energies after the spell is performed.

Spells are metaphysical things, so you may not always notice the spell being performed. I do not offer any returns or refunds for a spell that has been completed or otherwise initiated. I will complete the art within the agreed-upon time, or otherwise notify you of a delay, at which time you will be given a choice to carry on with the commission or get a full, or partial, refund. If the commission for any reason gets cancelled before it is fully finished, you will not be given a full refund depending on how far I have gotten in my work on your commission. If the art is 50% completed, you will only get a 50% refund. If the art is only 20% completed, you will only get an 80% refund. Your payment is considered a donation and energy exchange for the time and work I have put into the art.

### **Terms**

By paying, you agree to the service as decided upon at the time of payment. I reserve the right to decline any following requests or changes after the initial agreement.

You will only use the art as agreed upon. If you do not have full commercial rights for the art, you will not use it as such.

You agree and acknowledge that while the art is commissioned for you, I am the original creator and thus reserve certain rights over the art unless otherwise stated in our arrangement for your commission.

You agree not to request that I copy any art that is copyrighted, excluding art such as fanart.
